Speaker: Dan Sounders, CSP

Luke Souders and Dylan Shields didn't know each other although their paths crossed often on their daily commutes. On January 19, 2021 their paths crossed violently and fatally. This presentation tells the story of their accident and provides personal accounts of the consequences of distracted driving for both the offender and the affected.

Dan Sounders, CSP has over 40 years of occupational health and safety experience working in a wide range of industry sectors. He is a member and past president of the ASSP Chesapeake Chapter. Currently Mr. Sounders is employed with Lagan US, LLC as the Health, Safety, Environmental and Quality Manager responsible for HSEQ for Lagan's North American operations. Mr. Sounders has presented Bad Things Happen, Two Good People to over 800 persons, including the ASSP Chesapeake Chapter and ASSP Region VI.
